We kindly inform that on April 1, 2022 PZWL Wydawnictwo Lekarskie Sp. z o.o. („PZWL”) and Wydawnictwo Szkolne PWN Sp. z o.o. („WSz PWN”) merged with „Wydawnictwo Naukowe PWN” S.A. („WN PWN”), resulting in the acquisition of PZWL and WSz PWN by WN PWN. As a consequence **PZWL and WSz PWN will be removed from the National Court Register.**

The process of the merger of the publishing companies is an important step in the implementation of our long-term strategy. It aims to simplify structures and optimize processes within the merging entities. This will allow for greater flexibility in working with our clients and partners. As a merged company, we will continue to provide quality and innovative solutions to support the knowledge acquisition process. We join together to carry out this mission even more efficiently.

As of April 1, 2022, WN PWN took over all rights and obligations from PZWL and WSz PWN resulting from contracts concluded by PZWL and/or WSz PWN and **formally there is no need to change these contracts**, unless such a need results from business reasons.

We ask you to take into account the merger of the above-mentioned companies in all documents issued to PZWL and/or WSz PWN (including VAT invoices) **starting from April 1, 2022 and use the following data:**
